

Privacy Policy

This Privacy Policy also applies to any other site that we have owned or operated, do own and operate or may own or operate in the future including social media sites (collectively, the “Sites”). Unless we say otherwise, all references to the Sites in these terms of use include all such Sites. These terms of use do not apply to your use of unaffiliated Sites to which any of the Sites may link to or direct you to.

The company knows that you care how information about you is used and shared, and we appreciate your trust that we will do so carefully and sensibly.

This notice describes our privacy policy. By visiting the Sites you are accepting the practices described in this Privacy Policy.

All information transmitted, printed or otherwise submitted to the Company via Sites shall be deemed to be the property of the Company and the Company shall be free to use such information for any lawful purpose as detailed herein.

What Personal Information Does the Company Gather?

The information we learn from customers helps us personalize and continually improve your experience at Sites. Here are the types of information we gather.

Information You Give Us:

We receive and store any information you enter on our website or give us in any other way. You can choose not to provide certain information, but then you might not be able to take advantage of many of our features. We use the information that you provide for such purposes

as responding to your requests, customizing future visits for you, improving our service, and communicating with you.

Automatic Information:

We receive and store certain types of information whenever you interact with us. For example, like many websites, we may use "cookies," and we may obtain certain types of information when your web browser accesses Sites. Although we may not be able to provide you with a personalized experience if we cannot recognize you, we want you to be aware that these tools exist.

What About Cookies?

Cookies are alphanumeric identifiers that we transfer to your computer's hard drive through your web browser to enable our systems to recognize your browser and to provide more personalized features. The "help" portion of the toolbar on most browsers will tell you how to prevent your browser from accepting new cookies, how to have the browser notify you when you receive a new cookie, or how to disable cookies altogether. Does the Company share the Information It Receives?

You can tell when another business is involved in your transactions, and we share customer information related to those transactions with that business.

Protection Of Sites And Others:

This site contains links to other sites and we are not responsible for the privacy practices or the content of such sites.

We reserve the right to release such information to law enforcement or other governmental officials as we, in our sole and absolute discretion, deem necessary to comply with the law.

We release account and other personal information when we believe release is appropriate to comply with law; enforce or apply this and other agreements; or protect the rights, property, or safety of Sites, our users, or others. This includes exchanging information with other companies and organizations for fraud protection and credit risk reduction.

With Your Consent:

Other than as set out above, you will receive notice when information about you might go to third parties, and you will have an opportunity to choose not to share the information.

How Secure Is Information About Me?

It is important for you to protect against unauthorized access to your password and to your computer. Be sure to sign off when finished using a shared computer.

What Choices Do I Have?

We Do Not Intend To Collect Data From Children

No part of Sites web site is structured to attract anyone under the age of 18.

Our Right To Contact You

We reserve the right to contact you regarding your account status and changes to subscriber agreements, privacy policy, or any other policies or agreements relevant to you.
